Diver safety is our main priority. It is also in my full understanding that my payment is non refundable if we already set sail but needs to go back due to bad weather or sea condition.**

DHOW & SPEEDBOAT TRAVEL (EVERYONE TO READ AND SIGN)

I _____, am about to participate in a **dhow trip or speedboat** travel to and from a dive site(s), or other location(s), I understand that hazards can occur during a **dhow trip or speedboat travel** including, but are not limited to, slipping or falling while on board, being cut or struck by a boat while in the water, injuries occurring while getting on or off a **dhow or a speedboat** and other perils of the sea. By signing this contract, I certify that I am fully aware of and expressly assume these and all other risks involved in travel on, and to and from the dhow or the speedboat, either as a certified diver, student diver, snorkeler or passenger. I understand that **7 Seas Divers**, its employees, agents or representatives, the **dhow or speedboat** owner or crew, Instructors or Divemasters may not be held liable or responsible for personal injury, death or property loss as a result of my participation in this dhow or speedboat trip howsoever caused. By signing this contract I have agreed that any picture taken while I was onboard or under the ocean, 7 Seas Divers has the right to publish on their website, advertisement or any social networking sites.

DIVER PROGRAMS CERTIFICATE OF UNDERSTANDING AND ASSUMPTION OF RISK

I _____, hereby affirm that I am aware that scuba diving has inherent risks which may result in injury or death. I understand that diving with compressed air involves certain inherent risks; decompression sickness, embolism or other hyperbaric injury can occur that require treatment in a decompression chamber. I further understand that the diving trips may be conducted at a site that is remote, either by time or distance or both, from such a decompression chamber or other medical facilities. I still chose to proceed with such dives.

I confirm that I am a scuba diver and hold a certificate/diving card from a **RECOGNIZED INTERNATIONAL DIVING/TRAINING ORGANIZATION** allowing me to participate in scuba diving activities below 12 meters or deeper depending on my level of certification or that I am under the direct supervision of a **CERTIFIED DIVING INSTRUCTOR**. I will inspect all of my equipment prior to the activity and will notify the dive professional(s) if any of my equipment is not working properly. Failure to do so is my responsibility.

I understand that skin and scuba diving are physically strenuous activities and I will be exerting myself during these diving activities. I affirm that I am fit to participate in scuba diving and understand that I have a responsibility to truthfully inform the dive professional(s) and the facility through which this diving is offered of my medical history.

I understand that no one may be held liable or responsible for any injury or other loss suffered or caused solely by me or results solely from my own conduct or any matter or condition under my control. In the absence of any negligence or other breach by the dive professional(s), the facility through which this experience is offered, 7 Seas Divers and any recognized international diving/training organization, my participation in this experience is entirely at my own risk.
